I refer to your email dated 14 June 2016 in which you request access to documents held by the Department of Immigration and Border Protection (the Department) under the *Freedom of Information Act 1982* (the FOI Act).

1 Scope of Request

You have requested access to the following documents held by the Department:

2 Authority to make decision

4 Decision on access

In accordance with section 17 of the FOI Act, the Department has used its computer system to produce one document that contains the requested information. The data produced in this document existed in the possession of the Department on 14 June 2016 when your FOI request was received.

The decision in relation to the document in the possession of the Department which comes within the scope of your request is to release one document in full.

5 Your Review Rights

Internal Review

If you disagree with this decision, you have the right to apply for an internal review by the Department of this decision. Any request for internal review must be provided to the Department within 30 days of you being notified of the decision. Where possible please attach reasons why you believe a review of the decision is necessary.
