**Scope of request**

*Documents detailing the number of people living in Australia unlawfully after their visas expired.*

*The documents sought includes a breakdown of the number of expired visas where people are not known to have left the country by visa type and country of origin or passport. Also sought is the number of such visas that have been expired for:*

- 1. Six or more months;*
- 2. 12 or more months;*
- 3. two or more years;*
- 4. five or more years and*
- 5. 10 or more years.*

*I also wish to know the number of people expelled from Australia after their visas expired for each of the years 2011, 2012 and 2013, and from January 1, 2014 to June 30, 2014, with a breakdown for each of those periods of the visa types and countries or origin or passport.*

**Documents in scope**

1. Electronic document – Data about Unlawful Non-citizens - containing 1 folio.
2. Electronic document – Data about Departures (returned) – containing 12 folios

**Authority to make decision**

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access documents or to amend or annotate departmental records.

### **Information considered**

In reaching my decision, I have considered the following:

- The *Freedom of Information Act 1982*.
