Freedom of Information (FOI) request - Access Decision

On 4 September 2017, the Department of Immigration and Border Protection (the Department) received a request for access to document under the *Freedom of Information Act 1982* (the FOI Act).

1 Scope of request

You have requested access to the following document:

For 2016 and 2017 YTD please provide the number of 457 Visa applications to work in Tasmania for the occupation of Forester (ANZSCO code 234113) or production manager (forestry) (ANZSCO code 133511). Furthermore, please provide the number of these applications that have been approved, rejected, and have yet to be finalized.

2 Authority to make decision
