Dear Governor Benjamin

I am writing to provide an update on the Australian Government's infrastructure program in support of the Regional Processing Centre (RPC) in Manus.

The Australian Government is working with the PNG Government to ensure the facilities meet the current and future needs of the Centre.

Work is underway on Lombrum for:

- Improved amenities,
- An upgraded medical centre and kitchen,
- Upgraded support facilities and office accommodation for staff,
- A utilities/infrastructure hub,
- Accommodation for staff to replace accommodation currently provided on the Bibby Progress.

The overall RPC facilities on Lombrum need to cater for up to 1400 transferees and 600 staff.

In addition, Australia is funding on Lombrum 42 new and refurbished PNGDF houses at Upper Paradise coupled with a range of special purpose construction worker and staff accommodation buildings for the Papua New Guinea Defence Force.

At East Lorengau, we are building a facility that will be able to accommodate 298. As with Lombrum, site infrastructure at East Lorengau includes water and energy production, as well as a modern waste water treatment plant.
