**INSTRUMENT OF DELEGATION
MAIDAM (Character and General Visa Cancellation)**

I, *The Honourable SCOTT MORRISON*, Minister for Immigration and Border Protection acting under subsection 496(1) of the *Migration Act 1958* (the Act):

1. DELEGATE MY POWERS under sections 501(3A) and 501CA of the Act, to the persons holding, or occupying, or performing the duties of a position at the level and at the location specified in each Schedule to this Instrument.

This instrument MAIDAM (Character and General Visa Cancellation Powers) comes into effect the day after Royal Assent of the *Migration Amendment (Character and General Visa Cancellation) Act 2014*.
