- (2) classified under a subheading of Schedule 3 to the Customs Tariff Act 1995, specified in Item 62 in Part III of Schedule 4 to the Customs Tariff Act 1995;
- (3) entered for home consumption not earlier than the start date, and not later than the finish date, by the person specified in that Determination, as shown in Part 2; and
- (4) in total, not in excess of such quantity as is specified in that Determination, as shown in Part 2.

In pursuance of Section 273B of the Customs Act 1901, notice is hereby given that a Determination specified in Section B of Part 2 amended a previous Determination by deleting the figures in the column headed "QUANTITY AS WAS" and inserting the figures in the column headed "QUANTITY NOW IS".
